All of the inherent risks of skiing and snowboarding present the risk of serious and/or fatal injury.

In consideration of being permitted to participate in the activities offered at Ski Butternut, I, individually and on behalf of my heirs, executors, administrators, successors, agents, attorneys, assigns and legal representatives, hereby agree to release, waive and discharge Butternut Basin Inc. and I.E. Inc., their agents, employees, directors, officers, and shareholders, from any and all past and future liability for personal injury or property damage arising out of or related to the activities offered at Ski Butternut, whether caused by the negligence of Butternut Basin Inc. or I.E. Inc. their agents, employees, directors, officers, and shareholders, on or about the premises and facilities, or related to the operations of the ski area including, but not limited to, grooming, snowmaking, lift operations, actions or omissions of employees or agents of the area, or my participation in skiing, snowboarding or other activities at the area. - SEASON PASS USAGE** May only be used by Passholder. Transfer, or the attempt to transfer will result in revocation of the pass without refund, and is punishable under MA THEFT OF SERVICES LAW. Your season pass must be presented to any authorized Butternut representative upon request. It must be displayed on your outer garment at all times and be easily visible to ticket checkers.
- 3-PACK USAGE** Vouchers are transferable and all three may be used on the same day. Vouchers cannot be exchanged for other products.
- LOST** Report season pass loss to Main Office immediately. \$50 fee will be charged for season pass replacement. Misplaced or stolen 3-Pack vouchers will not be replaced by Ski Butternut.
- FORGOTTEN** Season Pass or 3-Pack voucher. A full price lift ticket must be purchased.
- CORPORATE PASS** A transferable season pass which displays your company's name.
- AGE DEFINED AS PERSON'S AGE AT TIME OF PURCHASE.**
- REFUND POLICY** There are no refunds on any products for any reason.
- EXPIRATION** 16/17 Season Passes and 3-Packs expire on the last day of the season or April 10, 2017, whichever comes first.
